
**INVITATION TO BID**  
**Procurement of Two (2) Units Vehicle**  
**For Official Use of DENR R8-PMD and Finance Division**  
**P.R. No. 2022-05-0008NCB**

1. The **DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES – REGIONAL OFFICE 8 [DENR RO8]**, through the **FY 2022 General Appropriation Act - RA No. 11639** intends to apply the sum of **Three Million Eight Hundred Thousand pesos & 00/100 [Ph3,800,000.00]** composed of **two (2) Units Vehicle** being the ABC to payments under the Contract. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
2. The **DENR RO8** now invites bids for the above Procurement Project. Delivery of the Goods is required by **thirty [30] calendar days**. Bidders should have completed, within **two [2] years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.  
  
Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from **Procurement Section, DENR RO8, 1<sup>st</sup> Floor, Administration Main Building, Tacloban City** and inspect the Bidding Document at the address given below during office hours from **8:00a.m. – 5:00 p.m., Monday to Friday** except Holidays.
5. A complete set of Bidding Document may be acquired by interested bidders on **May 27, 2022 to June 20, 2022, Monday-Friday from 8:00 p.m.–5:00 p.m.** at the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand pesos [Ph5,000.00]**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees as maybe presented in person, by facsimile, or through electronic means.
6. The **DENR RO8**, will hold a **Pre-Bid Conference** on **June 06, 2022, 2:00 p.m.** at **DENR RO8, 2<sup>nd</sup> Floor, Multi-Purpose Building, Sto. Niño Extension, Tacloban City** which shall be open to prospective bidders through personal and video conferencing with link to be provided for the schedule upon submission of request for participation thru email address **psdenr08@gmail.com**.

7. **Bids in sealed envelope must be duly received** by the BAC Secretariat through manual submission at the office address indicated below on or before **June 20, 2022, 12:00 noon. Late bids shall not be accepted.**
8. All Bids must be accompanied by a **bid security** in any of the acceptable forms and in the amount stated in **ITB Clause 14** and as listed hereunder.
