- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- Prospective Bidders may obtain further information from Procurement Section, DENR RO8, 1st Floor, Administration Main Building, Tacloban City and inspect the Bidding Document at the address given below during office hours from 8:00 a.m. 5:00 p.m., Monday to Friday except Holidays.
- 5. A complete set of Bidding Document may be acquired by interested bidders on April 28, 2023 to May 22, 2023, Monday-Friday from 8:00 p.m.-5:00 p.m. at the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand pesos [Ph5,000.00]. The Procuring Entity shall allow the bidder to present its proof of payment for the fees as maybe presented in person, by facsimile, or through electronic means.
- 6. The DENR RO8, will hold a Pre-Bid Conference on May 8, 2023, 2:00 p.m. at DENR RO8, 4th Floor, PMD Conference Room, Admin. Main Building, Sto. Niño Extension, Tacloban City which shall be open to prospective bidders

- 7. Bids in sealed envelope must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before May 22, 2023, 12:00 noon. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a **bid security** in any of the acceptable forms and in the amount stated in **ITB Clause 14** and as listed hereunder.
