TERMS OF REFERENCE (TOR)

ON THE CONDUCT OF PUBLIC AUCTION/SALE OF

SIX HUNDRED FORTY-NINE (649) PIECES OF LOGS WITH AN EQUIVALENT

NET VOLUME OF THREE HUNDRED SEVENTEEN POINT THIRTY-FOUR (317.34) CU.M. FROM
THE PAD DEVELOPMENT/ ACCESS ROAD CONSTRUCTION INSIDE THE PNOC RESERVATION

NOW UNDER EDC IN ORMOC CITY.

I. RATIONALE

Pursuant to the Provisions of Presidential Decree No. 705, as amended, and pertinent policies, rules and regulations of DAO 97-32 dated October 10, 1997 which subject, quoted "1997 Rules for the Administrative Jurisdiction of Illegal Forest Products and the Machinery, Equipment, Tools and Conveyances used in Connection Therewith" and in consonance with the authority issued by OIC, RED Tirso P. Parian in his memorandum dated August 23, 2021 on re: Clearance to dispose through public auction the felled trees/logs, a Public auction/sale shall be conducted over the six hundred forty-nine (649) pieces of logs with an equivalent net volume of three hundred seventeen point thirty-four (317.34) cu. m. from the PAD development/ access road construction project inside the PNOC reservation now under EDC in Ormoc City.

The Public Auction/Sale shall include the following Terms and Conditions:

- The above-mentioned forest products shall be sold to the highest bidder as determined herein and the said forest products may be inspected by the prospective bidder three (3) days before the date of sale. Assessment of the logs shall be based on the gross volume without benefit of conducting for rot cavities, or natural defects.
- 2. The minimum amount for the bid proposal for the subject forest products shall not be less than the total floor price as determined by the DENR including specific taxes, surcharges or penalties thereon.
- 3. Before commencing the bidding, all bidders shall be required to register their names together with the Residence Certificate as well as their Tax Account Numbers.
- 4. Bid tender shall be accepted before the actual sale and it shall be accompanied by either cash deposit, cashier's or manager's check in the name of DENR-PENRO Leyte

- equivalent to ten (10%) of the amount of the bid for a particular Lot of which deposits shall be returned to the losing bidder after the award is made.
- The opening of the bid tenders shall be done by the Committee on Bids and Awards on Forest Products and maybe witnessed by the bidders or their duly designated representatives.
- 6. After the opening of all bid tenders, the forest products shall be awarded by the PENRO Leyte Bids and Awards Committee (PBAC) to the bidder who shall have offered the price equal or higher than the total floor price. In case of tie, a new bidding shall be conducted immediately between or among the tied bidders until such tie is broken.
- 7. The ten (10%) percent bid value deposited by the awardee shall be automatically converted into partial payment and failure of the awardee to remit/pay the balance of the amount of the bid on or before 2:00 o'clock in the afternoon of the third working day from the date of sale will render the award null and void and the 10% deposit shall be forfeited in favor of the government.
- 8. Unless otherwise indicated, the forest products shall be offered for sale in "AS IS WHERE IS" scheme and the DENR shall not give warranty as to their condition.
- 9. Where goods are put up for sale by auction in lots, each lot is the subject of separate contract of sale.
- 10. Nature of forest products listed in the Notice of Sale is subject to exact determination before delivery and in case of any excess discovered, the same shall be withheld and withdrawn unless the buyer is willing to increase the bid price proportionate to the number/volume/quality of excess forest products, and in case of shortage discovered, inspection by bidder of the forest products offered for sale shall be ground to nullify the bidding proceeding. In the event the highest bidder refuses to accept the award, the ten (10%) percent cash deposit shall be forfeited in favor of the government and the bid of the second higher bidder shall be immediately recognized and accepted.
- 11. Storage fee shall be imposed on forest products awarded but not claimed within ten (10) days from the date of award and goods withdrawn after twenty (20) days from the date of award will be deposited rebidded and all moneys including the ten (10%) percent bid deposit will be considered forfeited.
- 12. The said forest products or logs being auctioned shall only be awarded and released to the winning bidder after the same shall have been duly inspected by the Commission on Audit (COA) inspection team.

II. QUALIFICATIONS OF BIDDER

Prospective bidders must be a qualified Wood Processing Plant holder preferably from this region who can provide legitimate supply of wood materials in the locality. He/she must submit the following:

- 1. Valid Mayor's Permit
- 2. Valid Wood Processing Plant Permit.
- 3. Notarized affidavit declaring that he/she is not related up to 4th degree in affinity or consanguinity to the chairman and/or any member of the Bids and Award Committee responsible for this bidding process.

Absence of any of the above documents shall be valid ground for disqualification of the bidder.

The envelope containing the bids should be sealed and marked "BID" for SIX HUNDRED FORTY-NINE (649) PIECES WITH AN EQUIVALENT NET VOLUME OF THREE HUNDRED SEVENTEEN POINT THIRTY-FOUR (317.34) CU.M. FROM THE PAD DEVELOPMENT/ ACCESS ROAD CONSTRUCTION INSIDE THE PNOC RESERVATION NOW UNDER EDC IN ORMOC CITY.

The PBAC reserves the right to reject any or all bids, or to accept such bids as maybe advantageous to the government.
