

## REQUEST FOR EXPRESSION OF INTEREST FOR PROVISION OF CONSULTANCY SERVICES OF SERVICE PROVIDER FOR OFFICIAL USE OF DENR PENRO SAMAR-SINP

- 1. The Department of Environment and Natural Resources Provincial Environment and Natural Resources Office, Samar (PENRO Samar), through SAA No.: PWS-22-02-009 intends to apply the sum of Thirteen Million Pesos & 00/100 (Php 13,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for PROVISION OF CONSULTANCY SERVICES OF SERVICE PROVIDER FOR THE OFFICIAL USE OF DENR PENRO SAMAR- SINP (PR 2022-07-0225). Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.
- 2. The PENRO Samar now calls for the submission of eligibility documents for PROVISION OF CONSULTANCY SERVICES OF SERVICE PROVIDER FOR THE OFFICIAL USE OF DENR PENRO SAMAR-SINP within Three Hundred Sixty Five days (365) days work duration for the following breakdown of ABC per deliverables and as stated in the Technical Specifications of this bid document:

Eligibility documents of interested consultants must be duly received by the BAC Secretariat on or before August 22, 2022, 12:00 p.m., and Eligibility Opening/Check on the same day at 2:00 p.m. at DENR PENRO Samar Conference Room. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.
- 4. Interested bidders may obtain further information from **DENR-PENRO Samar**, **Brgy. Guindapunan**, **Catbalogan City** and inspect the Bidding Documents at the address given below **during office hours**, **from Monday-Friday at 8:00 A.M. to 5:00 P.M.**
- 5. A complete set of **Eligibility Documents** may be acquired on **August 14-22, 2022** by interested **Bidders** and **Bid Documents** on **August 22, 2022 to September 27, 2022** for shortlisted bidders at **DENR PENRO Samar**, **Brgy. Guindapunan**, **Catbalogan Samar** and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount per Lot/s as stated hereunder with bid security requirements:

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", and its Implementing Rules and Regulations (IRR). The short list shall consist of three (3) prospective bidders for Lot I and three (3) prospective bidders for Lot II who will be entitled to submit bids. The criteria and rating system for short listing are:

- 7. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the IRR of RA 9184.

  Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 8. The Procuring Entity shall evaluate bids using the **Quality-Cost Based Evaluation/Selection (QCBE/QCBS)** procedure with the herein weights allocated:

a. Technical proposal = 60 %b. Financial Proposal = 40 %

The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.

9. The contract shall be completed within three hundred sixty-five days (365) calendar days or twelve (12) months.
