**Invitation to Bid for Construction of Two Units One-Storey Samar Island
Natural Park (SINP) Holding Areas and Eco-Toilet**

1. The *Department of Environment and Natural Resources, Region 8 [DENR RO8]*, through the *GAA CY 2020* intends to apply the sum of **Three Million Three Hundred Fifty Thousand pesos & 00/100 [Ph3,350,000.00]** being the Approved Budget for the Contract (ABC) to payments under the contract for *Construction of Two Units One-Storey Samar Island Natural Park (SINP) Holding Areas and Eco-Toilet [P.R. No. 2020-09-0006NCB]*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *DENR RO8* now invites bids for *Construction of Two Units One-Storey Samar Island Natural Park (SINP) Holding Areas and Eco-Toilet* with the hereunder project name, location, ABC and duration per project:

Completion of the Works is required within the no. of days per project as stated above. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."
- Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from *Procurement Section, Administrative Division, DENR RO8, Tacloban City* and inspect the Bidding Documents at the address given below from *8:00 a.m.- 5:00 p.m.* during office hours.
 5. A complete set of Bidding Documents may be acquired by interested bidders on *October 02-26, 2020* from the address below and upon payment of the applicable fee

for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of *Five Thousand Pesos [Ph5,000.00]*.


It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The **DENR RO8** will hold a *Pre-Bid Conference* on *October 12, 2020, 2:00 p.m.* at *Conference Room, DENR RO8, Administrative Main Building, Tacloban City* which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before *October 26, 2020, 12:00 noon*. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on *October 26, 2020, 2:00 in the afternoon* at *DENR RO8, Administrative Main Building, Tacloban City*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The **DENR RO8** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
