INVITATION TO BID FOR

1. The Department of Environment and Natural Resources-Regional Office 08 (DENR R08), through the *GAA for CY 2020* intends to apply the sum of *One Million Nine Hundred Eighty Thousand pesos & 00/100 [Ph1,980,000.00]* being the Approved Budget for the Contract (ABC) to payments under the contract for **Procurement of Eighteen (18) Units Motorcycle for Official Use of DENR R8-SINP (P.R. No. 2020-09-0027)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The DENR R08 now invites bids for **Procurement of Eighteen (18) Units Motorcycle for Official Use of DENR R8-SINP (P.R. No. 2020-09-0027)** with the herein item:

1.	Motorcycle, 150cc maximum power	18 Units

Delivery of the Goods is required within *thirty [30] calendar days*. Bidders should have completed, within *two [2] years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from **Procurement Section, DENR R08, Administrative Main Building, Tacloban City** and inspect the Bidding Documents at the address given below during office hours at *8:00a.m. – 5:00 p.m.* from **Monday to Friday** except Holidays.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **October 02-26, 2020, 8:00 p.m.–5:00 p.m.** from the address below and upon payment of the

applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of *Five Thousand pesos [Ph5,000.00]*;


It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The **DENR R08** will hold a *Pre-Bid Conference* on *October 12, 2020, at 10:30 a.m., DENR R08 Conference Room, Ground Floor, Administrative Main Building, Sto. Niño Extension, Tacloban City*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below *on or before October 26, 2020, 10:30 in the morning*. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on *October 26, 2020, 10:30 a.m.* at *DENR RO 8, Conference Room, Ground Floor, Administrative Main Building, Sto. Niño Extension, Tacloban City*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The **DENR R08** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
