For Technical Requirements (2<sup>nd</sup> Envelope)

1. List of similar completed contracts, or list of experiences of members of CBSP that satisfies the technical requirements of the procurement.
2. Bidder's Quotation
3. Certificate that the CBSP has an existing bank account.
4. Updated Audited Financial Statement (AFS)

For Financial Requirement (3<sup>rd</sup> Envelope)


1. Proof that it has financial management system in place such as book of accounts, cash receipt books, cash disbursement ledger/book or subsidiary ledger.

Section III of FMB TB No. 30

1. Certification from the BLOU/MLOU that the beneficiaries is a resident where the project is located.
2. Certification from the BLOU and affirmed by MSWD that the beneficiaries is classified as poor, low income class, lower income class middle-income classification.
